

CLPBC Spring Meeting Minutes- Draft

5-2-2025 6:00 PM

Call to order at 6:00 pm

Board in attendance: Kathy Battle, Tim Highfield and Mark Zaun.

1. Reviewed fall membership meeting minutes with members in attendance.

Carol Ann Baumann made motion to approve without change, Pete Aleksynas second .

Minutes approved.

2. Dave Grinzinger has resigned as president.

Ask for a 5th board member volunteer. No volunteers, will revisit this at a later time. Later in the day Phil Walling, who had expressed he would fill in if needed, said he would indeed step in.

Board appointed Phil to position of Vice President.

3. Mark Zaun presented treasurers report on screen.

Starting balance, current balance. See attached treasurer report.

4. Mark Zaun went over court resurfacing funds projection. If dues go back to \$50 a year to raise funds. We would be approx. \$2500 short. This did not include the winter play profits.

Stressed if we watched the budget he is confident the funds will cover the cost. Dues are currently \$25 per year and we face fundraising for resurfacing. Fundraising it time consuming and labor intensive.

5. Court resurfacing; Mark has been in close contact with court resurfacing company to keep on top of estimate. When the time comes we will have three bids for the resurface job. Mark Baumann asked if CLPOC was doing their duty in maintaining courts. Mark explained the CLPOC is in line with other amenities like the tennis courts (every 7-8 years). Mark also explained that the club does not have to pay for resurfacing earlier than what CLPOC will pay for. We can go 7-8 yrs and not have the quality courts to play on like the tennis court conditions at times. That option is not a great plan for quality of play.

6. Dues for 2025-26 season will be \$50, with \$25 going directly to the court resurfacing fund.

7. Proposed summer court set up to include:

-Monday Normal play

-Tuesday: two non aggressive courts (Like winter play) and two challenge courts. (advanced, Intermediate)

-Wednesday normal play

-Thursday- Like Tuesday

-Friday- one or two courts for drills, mentoring, working on skills for a couple of hours.

-Saturday Drop in Ladder league

-Sunday- Open play

-Will look into a picnic table for far end of courts for challenge courts as suggested by a member.

- Dina Jachens suggested a children's summer pickleball program need in CL. The board for look for a volunteer who would be interested in heading up a summer youth program.

- Suggested evening training for adults for those who are still working.

-Motion was made by Marv to try the programming as described above. Pam Owens second. Vote. All in favor.

-Mark to make a chart of describing this play.

8. Pickleballs: Mark Z took inventory of the balls on hand. We need to decide on what balls to order next.

Onyx on non aggressive courts and Dura or Franklin on other courts. Mark will price out Franklins as that was the most desired amongst those in attendance.

9. Parking Passes: Passes are no longer needed only ones who need it are sponsored members. There are very few sponsored players. Mark to work with CLPOC about the minimum passes we need.

10. New Code for shed will change on May 29th. An email will go out to all paid members for the new code. Team reach group leaders will begin removing non members from those groups at that time as well.

11. Guenther Mittlestat is very ill. Sue Stanton proposed a fun day to honor Guenther. Open play and a pot luck might be the best way to get him out to the courts. Maybe a lob play. Sue Stanton will plan. Will use Team Reach Open Play group for announcements and pot luck sign up.

12. Tim Highfield: Winter Play. See stats.

Thanks to Kathy Meyer for all her hours of organizing winter play and to Tim for facilitating with the church. Dave Baker as well in the organizing.

448 hrs of play was open over the winter.

1919 people attended in total.

1761 people paid \$60, 157 paid \$3 per play, of the total of people playing.
